Location

Bessemer Drive is located within the Kelvin Industrial Estate of East Kilbride just 1 mile south of the town centre and approximately 12 miles south of Glasgow city centre.

The subjects benefit from convenient access to the Southern Orbital road that connects with the M77 travelling west. The A725 is located a short distance to the north and connects with the M74 via the Raith Interchange along with the M8 and M80 beyond.

Neighbouring occupiers include Anglian Windows, PSV Glass, Merson Signs and Adam Plastics.
